4. <u>MINUTES OF PREVIOUS MEETING</u>

5. <u>CORONAVIRUS – UPDATE</u>

To note that as no further restrictions have been introduced by Government in relation to the Omicron variant, regular activities continue to take place at the Town Council's community centres and sports pavilions. However, due to high infection rates bookings for parties and large gatherings are still not being taken and this will remain under regular review.

6. <u>CULVER LANE ALLOTMENTS</u>

To note that notice has been given on several allotments, which will be offered to people on the waiting list. ETC now has 12 allotments, 4 troughs and 1 raised bed vacant and in the process of being offered to those on the waiting list.

7. <u>LAKESIDE HEDGE</u>

To note that reports were received in December 2021 that an unknown person/s have been cutting down the hedge located on Lakeside. The situation is being monitored by the Park Rangers and a report has been made to the Police as this is considered criminal damage.

8. <u>TREES AT MILTON ROAD</u>

To note that the three replacement trees funded by ETC have now been planted in Milton Road. Wokingham Borough Council's Senior Specialist for Trees has advised that the trees have been planted at different locations to the original trees due to better soil quality and larger verge sizes.

9. <u>TREE REGISTER</u>

To receive any available updates from the Town Council's Tree Recording Group.

10. WBC GARDEN FOREST SCHEME

To note that Wokingham Borough Council has published details of its Garden Forest Scheme, a project designed to encourage residents to plant a tree in their own gardens.
