The appeal is in response to WBC's 'difficult financial situation' and is intended 'to gauge whether any external organisation or company is interested in any type of short, medium or long-term use of any of WBC's assets'.

## 12.1 <u>Residents' Training Session</u>

To note that a free training session for Earley residents on the use of defibrillators will be held at Radstock Lane Community Centre at 7.30pm on Thursday 21<sup>st</sup> September 2023. Leaflets advertising the session have been delivered to properties in the locality of the newly converted red telephone box (Wychwood Crescent) and the session will be further advertised on notice boards and the town council's website and social media page. The session can accommodate up to 50 people, spaces are free but must be booked in advance. The response so far has been extremely positive.
