100. APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllrs J Eastwell, C Jones, T Maher and A Mickleburgh.

101. DECLARATIONS OF INTEREST

Councillor Hare declared an interest in Agenda Item 7 - Town Council Grants, owing to his involvement with Trinity Church. Councillor Matthews declared an interested in the same agenda item in relation to her personal connection to Cianna's Smile.

103. MINUTES OF PREVIOUS MEETING

107. ELIZABETH ROOM

The committee noted that The Elizabeth Room, a newly refurbished space at Radstock Community Centre which has been designed for use by charities and voluntary groups, was formally opened by the Town Mayor on 15th March 2023. Members present who attended the opening praised the work carried out and the committee asked for the council officers involved in the work to be thanked. The Town Clerk reported that the response from the charity and voluntary sector had been very positive.

108. CORONATION

Councillors received the recommendations of the working party on ways to recognise the coronation of King Charles III and, following some discussion, it was:

RESOLVED that a tree would be planted on one of the Earley Walks at an appropriate time, with the possibility that the walk would be renamed in honour of the King. Officers will also look at putting bunting on some town council owned assets such as bus shelters/noticeboards at the time of the coronation.

109. POLICY REVIEWS

109.1 Councillors reviewed the Town Council's Annual Leave Policy and Sickness Absence Policy, to which minor amendments had been made.

It was **RESOLVED** to re-adopt both policies.

109.2 Councillors considered the new Anti-Fraud & Corruption Policy, Credit Management Policy and Staff Recruitment & Retention Policy which had been drafted.

It was **<u>RESOLVED</u>** to adopt all three new policies as presented.

110. PARTNERSHIP WORKING – WOKINGHAM BOROUGH COUNCIL

The committee received a report from the Town Clerk on her attendance at the 'Community Futures with Town and Parish Councils' event hosted by WBC, which was also attended by Cllrs S Matthews and R Cook. The Town Clerk reported there had been representation from various town and parish councils at the event, which was aimed at developing better working relationships between the borough council and the town/parish councils. Councillor Matthews added that the event had been positive, well supported and is a work in progress. WBC will be planning further meetings.
