#### 66. <u>INTERNAL AUDIT</u>

Councillors received a report on the appointment of Earley Town Council's internal auditor, as requested. It was noted that the current internal auditor has in depth knowledge/understanding of Town/Parish Council finances as well as an understanding of ETC's broad range of activities and service delivery. Councillors were reassured that the internal auditor continues to have a professional and impartial approach.

The appointment of the internal auditor is reviewed annually, at the end of each audit cycle. Councillors were of the view that they would be comfortable with the appointment then continuing for a further 12 months, but that consideration should be given to changing the appointee at the review after that.

#### 68. YOUTH SERVICES - UPDATE

Councillors received an update on youth services and were pleased to note that ETC officers have continued to work with Berkshire Youth and that the launch of a Youth Club at Centrepoint Community Centre for 9 -11-year-olds, would be taking place on Thursday 23<sup>rd</sup> January, 5pm – 6.30pm.

The Town Clerk reported that Berkshire Youth had attended an assembly at Radstock Primary School and that the school was now supportive of the initiative but other schools in Earley had shown very little engagement. Berkshire Youth had reported that 8 children were currently signed up to the launch session.

Councillors thanked ETC officers for their work on this and looked forward to further feedback once the Youth Club has held more sessions.
